The Citizens Oversight Committee of the City of Westminster, California convened on June 18, 2020 at 10:03 a.m. in a Special Meeting in the East/West Room located at 8200 Westminster Boulevard, Westminster, California.

ADMINISTER OATH OF OFFICE TO MARK LAWRENCE

ORAL COMMUNICATIONS: Terry Rains, Westminster, spoke in regards to the sunset of Measure SS and shared she felt Covid-19 has negatively impacted the current budget, suggested an annual budget instead of fiscal and questioned how the business loans impacted the current budget.

1. Introduction and swearing in of New Member:

New Committee Member Mark Lawrence was introduced and sworn in by Acting Finance Director Erin Backs.

2. Special Presentations:

Acting Finance Director Erin Backs gave a brief update and overview on Measure SS funds.

Chair Carey requested all to watch the June 10, 2020 City Council Meeting for the full staff report with a presentation and also included Council Members comments and asked for Trust 115 Fund description.

Interim City Manager Sherry Johnson explained 115 Trust Funds regarding CalPERS and retirement.

Chair Carey asked what payment options were available regarding the Small Business Loan Deferral and how the business would make payments, she added she would like to see the loans continue so the City can help businesses. Interim City Manager Johnson shared businesses currently have two deferred options. The City can use current reserve to get through the year. She stated she does not was not want to lay off staff as the City currently has small staff and larger workload, the City is looking for ways to conserve and organize during this difficult time. She stated these are short-term fixes, but reassured she is looking into long term ways to save and bring in money to the City. The current budget will be brought before Council for approval with the addition of intentions to work hard to bring new ideas and more funds to the City.

Chair Carey commented the City had not yet recovered from the 2012 deficit when Measure SS passed, the funds helped, but with Covid-19, it may negatively affect the police department and its staff may face potential layoffs.

Chair Carey reiterated City employees cannot advocate for or against a tax measure, but can educate residents. Stated Measure SS is designed to help the City and not fix all financial issues. Spoke in regards to CPU and how important it is to keep them employed as they assist Code Enforcement and help keep the City clean, which helps keep property values high.

Committee Member Pearson questioned if unallocated project funds will be returned and if so, where the funds would be pulled from.

Interim City Manager Johnson stated \$2.4 million was transferred back to the General Fund account from the capital project set up from fiscal year 18-19.

Committee Member Seid questioned if allocated funds could be transferred back to General Fund and shared he feels the parks currently closed due to Covid-19 are perks and feels the City should focus on more important issues than parks and projects.

Interim City Manager Johnson indicated City Council can stop or put a hold on a project if it has not been started and welcomed residents to attend council meetings to share their comments and suggestions.

Committee Member Seid asked for clarification as to why the City is worried about renovating the Boys & Girls Club and asked the monies from those renovating projects be transferred back to general fund.

Committee Member Lawrence spoke on the importance of revamping the Boys and Girls Club to make it safe and the benefits they offer the kids who attend. Chair Carey questioned on who owns the Boys and Girls Club and expressed the importance of cleaning up the City.

City Traffic Engineer/Acting Assistant to the City Manager Ozaeta further explained the difference between Code Enforcement and CPU duties and clarified the Boys and Girls Club is owned by the City.

Committee Member Lawrence asked what other ways of revenue the City is looking into and asked if they considered marijuana dispensaries, suggested a higher tax on those industries, also stated he would like the City to look in to alternative options as he does not want to see staff laid off. Asked for clarification as to what Measure SS will consist of if placed on current ballot.

Interim City Manager stated marijuana dispensaries are controversial and have to see if residents are open to allowing sales, added she would like to look for other services and options for revenue before turning to layoffs.

Chair Carey expressed concern and the importance of Measure SS going on the ballot for the November 2020 General Election, stated if it does not pass it won't be able to go on the ballot for another two years at the next General Election.

Interim City Manager stated to place on the ballot for the 2020 General Election the cost would be less to the City than if called for a Special Election, suggested an increase to the current tax increase to 1.5% with no sunset. Added Chair Carey will speak at the June 24, 2020 City Council Meeting and will present a brief overview of the benefits of the Transaction Tax.

Chair Carey responded to oral communication speaker and stated staff cannot change the budget cycle and expressed her concern in not wanting to see layoffs or cuts within the City.
