Motion was made by Committee Member Piker and seconded by Committee Member Pearson to have Chair Carey attend the study session on April 13<sup>th</sup> and state that the committee is happy with the hiring so far but has concerns about the special election and to also mention the future effects of pensions on the City and to be careful with high projections of SS funds falling short.
