Homeless Enforcement Sections

Title 8 Health and Safety

- **8.16.040 Dumping prohibited** No person shall throw or dump any refuse on any public or private place
- **8.16.090 Removal of refuse** Any refuse discarded items placed on private property open to public view shall be removed immediately.
- **8.20.030(E) Storage of Discarded Materials** Illegal to store any materials in such a manner or condition detrimental to public health, safety, general welfare, or to nearby properties.
- **8.20.030(R) Living in Recreational Vehicle** Cannot use a recreational vehicle as a temporary or permanent living space
- **8.52.010 Outside trailer park—Prohibited** The use of a house trailer for purposes of temporary or permanent established trailer park is prohibited.
- **8.74.050** Removal of shopping carts from retail establishments prohibited Illegal for anyone but the owner/representative to remove a cart from the premises of a retail establishment, unless written permission has been granted.

Title 9 Public Peace Morals and Welfare

- **9.16.040 Display of private parts prohibited** Illegal to expose private parts or buttocks in any public place.
- **9.36.010 Damaging property prohibited** No person shall willfully break or destroy a property within city limits.
- **9.36.030 Throwing objects prohibited** Unlawful to throw upon any public highway, road, street, alley or sidewalk, any object capable of causing injury, or toward any person or vehicle within public right-of-way.
- **9.38.040 Anti-vandalism provisions** No person shall:
 - Graffiti prohibited on any public or privately owned property within city limits.
 - Possession of graffiti implements while in any public park, playground, or infrastructure used by the public.
- **9.48.010 Firearms—Discharge prohibited** No person shall shoot or discharge any gun, compressed-air gun, rifle, pistol or other firearm within the city.
- **9.68.010 Prohibitions** No person shall drink or consume any alcoholic beverage or possess any open container in a public place.

9.16.100 Public excretion prohibited – No person shall urinate or defecate in a public place, public view, or private place without owner's consent.

Title 10 Vehicles and Traffic

10.36.090 Freeway use restrictions - No person can ride a bicycle on a freeway

Title 12 Streets, Sidewalks and Public Places

12.24.030 Park property – No person shall:

- -Deface park property
- -Fail to maintain restroom in sanitary condition. Cannot use opposite sex public restroom
- -Dig or remove any dirt/sand shrubbery or plants
- -Construct or erect any building or structure

12.24.040 Sanitation - No person in a park shall:

- -Throw anything into specific bodies of water that may result in pollution of the water
- -Trash shall be placed in proper receptacles
- -Ride bicycles on other than paved path
- -Must ride on the right side of the path

12.24.050 Prohibited acts – No person in any park or public property shall commit the following acts:

- -Drink intoxicating beverages in the park
- -Have fireworks or explosives
- -Dogs unrestrained
- -Appear in any place other than proper clothing
- -Attempt to build a fire
- -Enter an area posted "Closed to the Public."

12.28.040 Storage of personal property in public places – Store any property in any park, street, or public place

12.28.030 No use of camp paraphernalia – No camp paraphernalia in any street, public parking lot, or public area

12.32.040 All solicitations prohibited at specified locations – Public streets

- -Soliciting from an occupant of an un-parked vehicle
- -No occupant of a vehicle can solicit from a person on a public street
- -No soliciting or loitering in median of designated streets
- -No solicitation within 15 feet of entrance or exit of a financial institution
- -No solicitation with 15 feet of an ATM
