The information on this list is subject to change without further notice from the City and the City is not responsible for the accuracy of the information provided. It is your responsibility to confirm that the testing company you hire meets all legal requirements to perform backflow testing and/or any repair work that may be required.

Any testing company testing a device in the City is required to have personnel certified with a current Orange County backflow testing device certificate and have a current license to do business in the City of Westminster. Please note that if the testing company will be performing any repairs to a backflow device that exceeds \$500, the company must also have a State contractor's license. Also, if you are the owner of the device and perform any repairs of your own on the device, you must submit to our office the listed repairs, parts used and have the device re-tested.
