Thereafter, each person speaking in favor or in opposition will have three minutes to speak. The total time for speaking in favor or in opposition may not exceed 30 minutes. Persons speaking in rebuttal will have three minutes each, or a total of 20 minutes for rebuttal. Anyone who wishes to address the Planning Commission on any matter, whether it appears on the agenda or not is requested to complete a "Request to Speak" form, available in the lobby of the Council Chambers.

VI. PUBLIC HEARINGS

A. Case 2006-56 Conditional Use Permit, Site Plan Review, Design Review.

The proposal involves the construction of a new, 2,500-square foot, single story building for the establishment of a single-tenant automobile repair facility. The proposed site location is between 7185 – 7195 Westminster Avenue (Assessors Parcel Numbers: 096-084-15 and 096-084-27).

B. Case 2006-73 Conditional Use Permit.

Conditional Use Permit request to allow the sale of individual containers of beer at an existing 7-Eleven Market/ CITGO Gasoline Station, thereby amending the conditions of approval of the Conditional Use Permit C-1017-A, approved by the City of Westminster Planning Commission on October 10, 2001. The site is located at 15991 Magnolia Street (Assessor parcel #'s: 107-672-37 & 107-672-38).
