ONLY THOSE PERSONS WHO HAVE SPOKEN IN FAVOR WILL BE PERMITTED TO SPEAK IN REBUTTAL. SPOKESPERSON(S) DESIGNATED TO SPEAK IN FAVOR OR IN OPPOSITION WILL HAVE A TOTAL OF TWELVE (12) MINUTES TO SPEAK. THEREAFTER, EACH PERSON SPEAKING IN FAVOR OR IN OPPOSITION WILL HAVE THREE (3) MINUTES. THE TOTAL TIME FOR SPEAKING IN FAVOR OR IN OPPOSITION SHALL NOT EXCEED 30 MINUTES. THOSE PERSONS SPEAKING IN REBUTTAL WILL HAVE THREE MINUTES EACH, OR A TOTAL OF 20 MINUTES. THE PLANNING COMMISSION MAY USE ITS DISCRETION TO ALLOW A SPEAKER TO EXCEED TIME LIMITS.

A. <u>Case 2009-27 Conditional Use Permit Amendment</u>
<u>Location: 200 Westminster Mall (Assessor's Parcel Number 195-373-11)</u>
Target

An application filed for an amendment to a Conditional Use Permit to authorize the off-sale of distilled spirits in addition to the existing sale of beer and wine at a Target store located at Westminster Mall.

STAFF RECOMMENDATION: That the Planning Commission approve the Conditional Use Permit.

## B. <u>Case 2009-24 Zoning Text Amendment – Artificial Turf</u> Location: Citywide

Zoning Text Amendment (ZTA) to allow the use of artificial turf, subject to specific minimum performance standards and conditions. As proposed, current code prohibits the use of any artificial plant materials for multi-family residential, commercial, and industrial zones. Current code does not specifically address the use of artificial turf for R-1 (single family) zones. Continued from June 3, 2009.

STAFF RECOMMENDATION: That the Planning Commission recommend that the Mayor and City Council adopt an ordinance amending the current zoning regulations to allow the use or application of artificial turf subject to specific minimum performance standards and conditions

# C. <u>Case 2009-12 Zoning Text Amendment – Parking Requirements</u> Location: Citywide

Zoning Text Amendment (ZTA) to section 17.46.040 of the Westminster Municipal Code, which will reduce the amount of parking spaces required for retail food and beverage service businesses offering twelve or fewer seats.

STAFF RECOMMENDATION: That the Planning Commission recommend that the Mayor and City Council adopt an ordinance amending section 17.46.040 of the Westminster Municipal Code to reduce the amount of parking spaces required for retail food and beverage service businesses offering twelve or fewer seats.
