## 8.1 Case No. 2011-68 Zone Change and Conditional Use Permit (ZC, CUP). .

**Location:** 13561 Beach Boulevard

**Applicant:** William O. Lewis for Bremco Construction

The applicant proposes to rezone two adjoining vacant parcels (with a combined area of 27,500 square-feet) to the C-2 (General Business) Zoning District. One of the two parcels is within the R1 (Single-Family Residential) Zoning District, while the other parcel is within the C1 (Local Business) Zoning District. The applicant is also requesting a Conditional Use Permit (CUP) to develop the two parcels as an un-manned parking lot to store up to 40 vehicles that will be sold at a nearby used car sales lot (located at 13631 Beach Boulevard), on the southwest corner of 23<sup>rd</sup> Street and Beach Boulevard. No buildings are proposed at the subject site, neither is the sale and/or repair of vehicles proposed at the subject site.
