8.1 Case No. 2012-37. An application for a Conditional Use Permit and Development Review at 10002 Bolsa Avenue. (Assessor's Parcel Number 108-010-36).

The project involves the development and operation of a 2,426 square-foot, 23-foot high; (at the highest point), approximately 85 feet long and 27 feet wide, self serve drive-through car wash on a vacant 19,268 square-foot lot. The use also includes 12 self-serve vacuums with 14 associated parking stalls.

Planning Manager, Art Bashmakian, gave a presentation on the item.
