- 7. APPROVAL OF MINUTES: Regular Meeting of February 6, 2013.

The minutes of the regular meeting of February 6, 2013 were approved on motion of Vice Chair Anderson, seconded by Chairman Nguyen with a minor edit on page 1 and carried 3-0 (Ho absent).

- 8. PUBLIC HEARINGS -
- 8.1 Case No. 2012-72 Variance (V). An application to replace an existing 7-foot high wall with a 14-foot high wall along a 53-foot section of the west property line where the maximum allowed height is 8-feet.

Location: 9200 Bolsa Avenue (Asian Garden Mall)

Applicant: Asian Garden Limited

RECOMMENDATION: Staff recommends that the Planning Commission grant the Variance.

Kelvin Parker, Senior Planner, gave a presentation on the item.

Commissioners asked questions for clarification.

Julie Newell, representing the applicant spoke in support of the project.

No one spoke in opposition.

THE CHAIR CLOSED THE PUBLIC HEARING

Chair Nguyen asked about any code enforcement cases.

Mr. Parker informed that code enforcement is aware of the billboard on the side of the building.

The Commissioners stated that the wall is acceptable.

CHAIR NGUYEN REOPENED THE PUBLIC HEARING

Chair Nguyen suggested a condition that the property comply with code relative to any violations related to signage along the east wall of the Asian Garden Mall.

The applicant concurred with the condition.

CHAIR NGUYEN CLOSED THE PUBLIC HEARING

Motion was made by Chair Nguyen, and seconded by Vice Chair Anderson, to approve the project and adopt Resolution No. 13-003 entitled, "A Resolution of the Planning Commission of the City of Westminster approving a variance to extend the height of an existing seven foot high wall to 14 feet along an approximately 53-foot section of the west property line at 9200 Bolsa Avenue with an added condition that any code violations be eliminated"

9. REGULAR BUSINESS:

9-1 Case No. 2012-16. A request from subject property owner for clarification regarding unpermitted nonconforming signage related to a previous decision by the Planning Commission when it approved a Conditional Use Permit for late night operation of a convenience store (7-Eleven).

Location: 8501Heil Avenue

RECOMMENDATION: Staff recommends that the Planning Commission clarify its decision that said signs cannot remain.

Chair Nguyen asked the City Attorney if the Commission can consider this matter since the applicant is not present.

The City Attorney stated that the Commission can proceed with the matter.

Vice Chair Anderson mentioned that this matter was already continued once at the request of the applicant, to this date.

Kelvin Parker, Senior Planner, gave a presentation on the item.

Chair Nguyen read conditions from the Planning Commission Resolution (related to approved the 7-11 project) making the point that the record was clear that said signs were to be removed.

Vice Chair Anderson mentioned that said signs are banners and that they constantly change. As such, the subject signs could not have been approved 30 or more years ago since the signs keep changing.

Commissioner Manzo mentioned about possible code violation related to storage of materials and mentioned that the wood frames have deteriorated.

Commissioner Manzo suggested that the existing freestanding sign could be used to advertise other businesses.

Motion was made by Vice Chair Anderson, and seconded by Chair Nguyen, that the Planning Commission finds that the signs are unpermitted and nonconforming and therefore should be removed and that if the property owners so chooses, he may apply for a variance for signage to replace said signs.

11. MATTERS FROM THE PLANNING COMMISSION

11.1 Request from Chair Nguyen to discuss the possible implementation of an awards program for quality development.
