8. PUBLIC HEARINGS

8.1 Case No. 2016-41 (Tentative Tract Map and Design Review)

Location: 7201 21st Street (APN # 096-051-14)

Applicant: 9 Max Capital, LLC.

An application to demolish existing single-family dwellings, and develop 16 residential dwelling units for condominium ownership

CEQA COMPLIANCE: The proposed matter is exempt from CEQA pursuant to Section 15332 (In-Fill Development) Class 32 which applies to projects characterized as in-fill development meeting the following conditions:

- a) The project is consistent with the applicable general plan designation, all applicable general plan policies, applicable zoning, and regulations.
- b) The proposed project development occurs within City limits on a project site of no more than five acres substantially surrounded by urban uses.
- c) The project site has no value as a habitat for endangered, rare, or threatened species.
- d) Approval of the project would not result in any significant effects relating to traffic, noise air quality, or water quality.
- e) The project site can be adequately served by all required utilities and public services.

RECOMMENDATION: That the Planning Commission continue the Public Hearing to a date unspecified as per request by the applicant received February 21, 2017.

Senior Planner Steve Ratkay stated that the applicant has requested an indefinite deferral of the item, he referred to a letter submitted by the applicant requesting the continuance.
