# CITY OF WESTMINSTER NOTICE OF PUBLIC COMMENT PERIOD & HEARING FY 2021/22 ANNUAL ACTION PLAN COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) & HOME INVESTMENT PARTNERSHIP (HOME) PROGRAMS

**NOTICE IS HEREBY GIVEN** that on April 28, 2021, at 7:00 PM or as soon thereafter as the matter may be heard, in a virtually held meeting with attendance and comment instructions attached to the City Council Agenda, the City Council will hold a public hearing to approve the FY 2021/22 Annual Action Plan and will accept public comments on the use of Community Development Block Grant (CDBG) and Home Investment Partnership (HOME) funds. The City Council Agenda and can be accessed online at <a href="https://www.westminster-ca.gov">www.westminster-ca.gov</a>.

The City must annually submit an Annual Action Plan (AAP) to the US Department of Housing and Urban Development (HUD), which specifies the activities that will be undertaken to meet the goals identified in the 2020/21 - 2024/25 Consolidated Plan. The AAP is due to HUD by May 14, 2021 and is subject to review and approval by HUD. The City of Westminster expects to receive \$982,459 in CDBG and \$445,517 in HOME funds for FY 2021/22 from HUD. Unspent, prior year funds are also available for reprogramming in FY 2021/22.

### COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG)

CDBG funds are designed to assist the City in its efforts to provide decent housing, a suitable living environment, community services and facility needs, and expand economic opportunities for primarily low-and-moderate income persons. The City may allocate a maximum of 15 percent of the annual CDBG entitlement to public service providers. Therefore, approximately \$147,368 is available to public service providers in FY 2021/22. The remainder of funds may be allocated to capital projects or capital improvements, and to administrative costs which are limited to 20 percent. Funds remaining from prior projects completed under budget may be allocated to supplemental City-initiated capital projects. Funding allocations as recommended to the City Council for FY 2021/22 are as follows:

#### **HOME**

The 2021/22 allocation of \$445,517 plus prior year HOME funds, minus the maximum of ten percent (10%) for HOME Program Administration, will be allocated to the Acquisition/Rehabilitation/New Construction Program for the development of affordable rental housing.
