1. Special Presentations:

Acting Finance Director Backs gave a brief update, with power point presentation, and overview on the 2020-2021 budget.

Committee Member Piker inquired if there is money in the budget to unfreeze positions and hire staff

Acting Finance Director Backs stated it may be possible to unfreeze and hire staff for needed position within the police department.

Chair Carey questioned if there were inquiries on the City hiring more police, Assistant City Manager, City Manager or other needed staff.

Assistant to the City Manager Ozaeta stated the police department is currently fully staffed.

Committee Member Lawrence asked if the police department was still giving lateral bonus as an incentive, stated it is encouraging to see restaurants and hotels with increased revenues as the County is slowly starting to open, and questioned if the state will withhold any grant or money for Counties not complying with the current executive orders.

Assistant to the City Manager Ozaeta stated certain counties and most states are complying with current orders to avoid losing funds, shared the community is providing services to residents with the funds given.

Chair Carey questioned if the City was currently in contact with legislator leads.

Assistant to the City Manager Ozaeta stated he has weekly contact with legislator leads, Senator Umberg, the Mayor of Santa Ana, and Orange County Mayor Coalition.

Committee Member Piker asked for data regarding layoffs COVID-related and inquired how this would impact the sales tax measure, and if budget numbers were updated to current month.

Acting Finance Director Backs is scheduled to meet with the consultant, but data is not current.

Assistant to the City Manager Ozaeta will inquire with Community Development Director Smittle regarding employment statistics, spoke in regards to two projects that will help tax and bring revenue to the City, the mall development is trying to provide balance of housing and business and referred to the article in Orange County Journal regarding brief overview of the project.

Committee Member Lawrence asked if the city of Huntington Beach is on board with the mall development.

Assistant to the City Manager Ozaeta stated he has been in communication with the City of Huntington Beach about the possible development and specific plan, the community would like a place to enjoy and not just shop and compared new development to Victoria Garden Mall (San Bernardino County).

Committee Member Piker questioned if the funds from the Westminster Mall development will compensate funds with Measure SS not being on the ballot.

Acting Finance Director Backs clarified funds from the mall project will provide some revenue, but not compared to the revenue the City receives from Measure SS, she will discuss budget with council, noted on record there was a correction to the minutes being approved at today's meeting.

Chair Carey asked for an update on the Westminster Mall project and clarification on where we are at on state and federal level.

Committee Member Piker questioned if there will be additional meetings with council to place the sales tax measure on the ballot and asked what additional revenues would help the City.

Acting Finance Director Backs clarified if measure is placed on a ballot, it would be a special election.

Discussion ensued regarding the importance of having Measure SS and the concerns if the measure is not passed.
