1. ORAL COMMUNICATIONS

Terry Rains, Westminster resident, offered information about the Regional Housing Needs Assessment (RHNA) requirement for the City of Westminster. She felt the extremely low and very low income demographic was not realistic in the allocation. She suggested that more partnerships be formed with developers to provide rental units to residents based on tenant income.

Jodi Boyd, Westminster resident, offered that new housing units will give the City a facelift and has the potential of providing lower rents to residents as additional units are built. She added, by leveraging the grants, the funding, and the developers that we need, the City will be able to achieve their housing goals.

2. PRESENTATION ON HOUSING ELEMENT UPDATE

Alexa Smittle, Community Development Director, provided an introduction to the Housing Element Update presentation. She explained that the Housing Element is a component of the General Plan, but it has a separate update cycle requiring an update every eight years.

Amanda Tropiano, Principal Planner with De Novo Planning, provided a PowerPoint presentation to the City Council members and Planning Commission members. The presentation included:

Council Member Manzo, Council Member Ho, and Planning Commissioner Anderson inquired about the following:

- Shared housing model found on the Housing and Urban Development (HUD) website and if it might be a solution to satisfy the RHNA housing units allocated to the City.
- The use of accessory dwellings to meet RHNA housing units allocated.
- The role of City owned sites in meeting the RHNA housing units allocated.
- If homelessness will be addressed with the RHNA housing units allocated.
