SPECIAL NOTICE REGARDING CORONAVIRUS (COVID-19) AND ATTENDANCE AT PUBLIC MEETINGS

On March 4, 2020, Governor Gavin Newsom proclaimed a State of Emergency in California as a result of the threat of COVID-19. On September 17, 2021, Governor Newsom signed AB 361 related to the Brown Act and remote meetings during the state of emergency. AB 361 allows local agencies to continue to conduct remote or “Zoom” meetings during a declared State of Emergency. The City Council adopted Resolution No. 5067 on September 22, 2021, determining as a result of the emergency, meeting in person would present imminent risk to the health or safety of attendees. The City Council shall make this determination every 30 days. Pursuant to AB 361, please be advised that some or all of the Westminster Planning Commission Members will participate in meetings via teleconference/web conference.

PROJECT DESCRIPTION: A Conditional Use Permit (CUP) proposal to allow for the incidental off-site sales of beer, wine, and distilled spirits (Type 21 Alcoholic Beverage Control License), in conjunction with a proposed 1,653 square foot convenience store, with incidental sales of tobacco.

CEQA COMPLIANCE: The proposed project has been reviewed pursuant to the California Environmental Quality Act (CEQA) and the requirements of the City of Westminster. If the project is approved, the project would be deemed to be categorically exempt per Class 1 Section 15301 of the California Environmental Quality Act (CEQA)

because the project consists of the operation, repair, maintenance, permitting, leasing, licensing, or minor alterations of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that existing at the time of the lead agency's determination.

If the requested application is denied, then CEQA does not apply to projects which a public agency rejects or disapproves under the provisions of CEQA Section 15270 (Projects which are Disapproved).

RECOMMENDATION: Staff recommends that the Planning Commission consider the requested Conditional Use Permit Case No. 2020-1215 to either approve or deny the applicant's request by adopting one of the two following resolutions:
