# ORDINANCE SUMMARY AND SECOND READING AND ADOPTION OF ORDINANCE NO. 2578

#### ORDINANCE NO. 2578

AN ORDINANCE OF THE MAYOR AND CITY COUNCIL OF THE CITY OF WESTMINSTER AMENDING TITLE 8, CHAPTER 16 OF THE MUNICIPAL CODE RELATING TO COMPREHENSIVE WASTE MANAGEMENT PROGRAM AND ADOPT BY REFERENCE MIDWAY CITY SANITARY DISTRICT'S SOLID WASTE REGULATIONS.

The Public Hearing is to consider the following Ordinance:

The Mayor and City Council will amend the Westminster Municipal Code, Title 8 Health and Safety, Chapter 8.16, relating to Comprehensive Waste Management Program and adopting by Reference Midway City Sanitary District's Solid Waste ("MCSD") Regulations MCSD Ordinance, in compliance with California State requirements of SB 1383, also referred to as the Short-Lived Climate Pollutant Reduction Act of 2016.

Said Solid Waste Regulations is to adopt, by reference of MCSD, an enforceable mechanism by January 1, 2022, to mandate the collecting, disposing, recycling, and reporting of organic waste and that organic waste generators, haulers, and other entities subject to the State requirements of SB 1383 regulations including commercial, industrial, and residential properties.

The SB1383 regulations set forth the enforcement and enforceable mechanism to implement relevant regulations, such as to reduce the amount of organic waste disposed of in landfills as follows: 75% reduction by 2025.
