## **SPECIAL NOTICE REGARDING CORONAVIRUS (COVID-19) AND ATTENDANCE AT PUBLIC MEETINGS**

On March 4, 2020, Governor Gavin Newsom proclaimed a State of Emergency in California as a result of the threat of COVID-19. On September 17, 2021, Governor Newsom signed AB 361 related to the Brown Act and remote meetings during the state of emergency. **PROJECT DESCRIPTION:** A City-initiated zoning text amendment and zoning map amendment, which includes: the establishment of new mixed-use zoning districts and regulations, the establishment of a new housing overlay zoning district, and the rezoning of certain parcels to a mixed-use zoning district, the rezoning of certain parcels to a housing overlay zoning district, and the rezoning of certain parcels to a residential zoning district, to be consistent with the Land Use Element and Housing Element of the Westminster General Plan, and to amend the City Design Guidelines Manual and adopt an addendum to the Westminster General Plan Final Environmental Impact Report.

**CEQA COMPLIANCE:** The City has reviewed and considered the Final Environmental Impact Report (FEIR) for the General Plan certified by the City Council on September 28, 2016 (State Clearinghouse No. 2015121052), including the impacts and mitigation measures identified therein. In compliance with CEQA Guidelines Section 15164, an Addendum to the General Plan FEIR has been prepared which concludes that the proposed updates to the Zoning Code do not result in any new or greater environmental impacts than were previously analyzed, disclosed, and mitigated. None of the conditions in CEQA Guidelines Section 15162 that require the preparation of a subsequent EIR are present; therefore, no additional environmental review is required. An Addendum to the Westminster General Plan FEIR is provided as Attachment No. 08. A link to the City's Adopted General Plan EIR at the City's website is provided as Attachment No. 09.
