- **a. Review of Draft Bylaws:** Christian Bettenhausen reported that the Articles of Incorporation of the Westminster Community Foundation (Foundation) were filed in the office of the California Secretary of State on May 18, 2023. A copy of the articles was distributed to the board, and the draft of the Bylaws were reviewed. Christian resigned as Incorporator and the board accepted his resignation as Incorporator with a motion being made by Julie Diep, all were in favor and the motion passed, 10-0.
- **b. Appointment of Officers:** Board members discussed the different positions outlined in the bylaws and made the following appointments:
