6. ORAL COMMUNICATIONS

Terry Rains offered that the Planning Commission had approved Case No. 2022-370 (PACE Elderly day healthcare facility) on May 3rd, and that Vice Mayor Nguyen called the project for a City Council review. She opined there was no legal basis for the City Council to overturn the Planning Commission approval. She spoke about a delay in processing Case No. 2022-0381 (Karaoke facility located within the Asian Garden Mall) and recent Planning Commission meeting cancellations due to a lack of business. She felt that the planning commission meeting cancellations unfairly delayed the businesses processing and offered that the City should do better to ensure new businesses are processed efficiently.

Discussion ensued regarding a request by Chair Bui for a copy of Ms. Rains written public comment. Ms. Rains declared that she only had one copy so she would not be able to provide it to all the Commissioners as required. She stated that she could provide it to the Planning Commission Clerk via email, who then could provide it to the Commissioners.
