- **10.1 PENDING HOUSING LEGISLATION 2023**

Deputy City Attorney Porter provided a PowerPoint presentation to the Commission regarding the pending housing laws awaiting to be signed into law. The following points were covered during the presentation:

- 61 New Housing Laws related to housing, surplus land, transitional housing, and CEQA.
- Most enrolled and are awaiting Governor's approval.
