#### 1. ORAL COMMUNICATIONS

1. Sharon Nicholas spoke about Captain Paul Jacobs and was in favor of installing a plaque to honor him at Sid Goldstein Freedom Park. She encouraged the commissioners to watch the documentary about the story of the USS Kirk and its crew called "The Lucky Few".

Commissioner Nguyen informed those in attendance that item 4.1 is coming up on the agenda and that anyone who would like to speak on that item is welcome to do so at that time.

#### 2. APPROVAL OF MINUTES

#### 2.1 Meeting held on Monday, October 24, 2022

#### 3. UNFINISHED BUSINESS

#### 3.1 Park Check List Reports

Commissioner Nguyen reminded the commission if they wanted to add any parks to their list, to let staff know. Commissioner Nguyen mentioned he would like to add Westminster Park to his list.

Commissioner Do asked staff to add Tony Lam Park to his list.

#### 3.2 Playground Project Updates

Jake Ngo gave a presentation on the upcoming playground projects which included timelines for the existing playground projects and information on upcoming new playground projects. He also informed the commission about the new pickleball courts coming to Sigler Park, ball diamond improvements, building improvements at Blakey Park and a new community garden.

Commissioner Do inquired about the location of the proposed pickleball courts at Bowling Green Park, Jake Ngo responded that staff is currently working with the contractor regarding the location of the proposed pickleball courts for Bowling Green Park and Westminster Park.

Commissioner Nguyen inquired about the environmental documents associated with proposed pickleball courts at Sigler Park and asked staff to make sure the consultant is aware of the potential noise issue from pickleball, especially since there is a church and homes nearby. Commissioner Nguyen also inquired about the size of the lot for the community garden.

#### 4. NEW BUSINESS

#### 4.1 Request to install a plaque at Sid Goldstein Freedom Park (Staff Report)

Vanessa Johnson presented the staff report and presentation to the commission regarding the request received to install a plaque at Sid Goldstein Freedom Park to honor the late Captain Paul Jacobs.

Jake Ngo informed the commission he met with the architect of the Vietnam War Memorial to review the location options proposed by the requester for the installation of the plaque. Jake Ngo reported on the potential issues of each proposed option and informed the commission that Option #4, rear left of the statues, would be the best option.

Commissioner Nguyen inquired about the different options.

Commissioner Nguyen asked the commissioners if they had any questions, seeing that there were no questions from the commissioners, Commissioner Nguyen welcomed any remaining speakers from the audience to speak on the item.

#### **Oral Communications Continued**

- Angelique Tran spoke about the late Captain Paul Jacobs and expressed her support for the installation of the plaque to honor him at Sid Goldstein Freedom Park.
- 3. Jackie Wright spoke about the late Captain Paul Jacobs and how great of a man he was. She expressed her support for the installation of a plaque to honor him at Sid Goldstein Freedom Park.

Commissioner Nguyen invited Sharon Nicholas to continue her speech from earlier in the meeting, since she previously ran out of time.

Sharon Nicholas spoke about events that have occurred to honor the late Captain Paul Jacobs and his crew and continued to speak about the documentary, "The Lucky Few". She mentioned her group would want the plaque to be installed in Westminster because of the large Vietnamese Community in the city.

4. Lacey Wright mentioned that he had met Captain Paul Jacobs and he was an honorable man. He expressed his support to have the plaque installed in Westminster, at Sid Goldstein Freedom Park.

Commissioner Nguyen asked staff to read the E-Comment received into the record.

Vanessa Johnson read the E-Comment received into the record.

#### E-Comment

 Robert. L. Harrison, USMC, Vice President Vietnam Veterans of America Chapter 1024; Vietnam War Memorial in Westminster Inc., agreed that the late Captain Paul Jacobs should be honored, but he did not agree with singling out any individual with recognition on the Vietnam War Memorial as it represents all South Vietnamese and American Veterans that fought in the Vietnam War. He expressed that the small plaque cheapens the accomplishments of Captain Jacobs, where he deserves much more recognition. He also expressed his concern that recognizing a particular individual would open the flood gates. He suggested having the plaque installed along the walkway, alongside other plaques. Commissioner Nguyen asked staff to show the walkway that the submitter of the E-Comment mentioned on the screen so that commissioners can take a look at that suggested spot.

After discussion about all of the proposed locations, commissioners agreed that Option #4, would be the best option.

**Motion was made by Commissioner Nguyen,** and seconded by Commissioner Do, to make a recommendation to the City Council to have the proposed plaque installed at option #4, rear left of the statues. Motion carried 3-0, with the following vote:

Jake Ngo mentioned they can definitely look into that.

### 1. SUBJECT

Request to replace two (2) panels on the wall inside the Vietnam War Memorial Kiosk.

# 2. RECOMMENDED ACTION/MOTION

The Parks and Recreation Commission should consider making a recommendation to the City Council to replace two (2) panels on the wall inside the Vietnam War Memorial Kiosk at Sid Goldstein Freedom Park.

# .3. BACKGROUND AND DISCUSSION

In accordance with Resolution No. 5094, the duties and responsibilities of the Monuments and Memorials Committee were reassigned to the Parks and Recreation Commission. These duties and responsibilities include serving in an advisory capacity to the City Council to provide an independent review of all new requests for proposed monuments, plaques, donor tiles, structures, markers, any other memorial, and modifications to existing monuments on any city property. The commission will also review a historical report that is to be provided with each proposal and forward its recommendations to the City Council for their consideration. Staff received a request for two (2) panels on the wall inside the

existing Vietnam War Memorial Kiosk at Sid Goldstein Freedom Park to be replaced with new pieces, which is now being presented to the Commission.

The proposal is to replace the existing two (2) panels that are currently on one of the walls inside the Vietnam War Memorial Kiosk for new aluminum sheet panels that include additional historical details of the Vietnam War. The Vietnam War Memorial Kiosk is located at Sid Goldstein Freedom Park,14180 All American Way.

The historical information on the new panels has been vetted by the late Lieutenant Colonel Craig Mandeville; Lam Nguyen, the Architect involved with the Vietnam War Memorial project; Robert Harrison from the Vietnam War Memorial in Westminster, Inc; Nelson Nguyen of the Vietnamese Community of Southern California; and various Southern Vietnamese Military who have attended Sid Goldstein Freedom Park events over several months.

The Vietnam War Memorial in Westminster, Inc., a non-profit organization involved with building the memorial, is proposing to replace the panels with the intent to provide additional important historical details of the Vietnam War for the park visitors, and for healing of both American and South Vietnamese Veterans who lived through the war. The map featured on the new panels was displayed on the H-1 helicopter taken to veteran and civic events and was in the Pentagon.

This project will be funded solely by the late Lieutenant Colonel Craig Mandeville, Vietnam Veterans of America Chapters 1024 and 756, and the Vietnam War Memorial in Westminster, Inc. The City will not incur any of these costs.

The Commission should review this request and make a recommendation to the City Council to consider replacing the current panels with the new proposed panels.

If the City Council approves this request, then City Staff will coordinate an installation date with the petitioners.

NOW, THEREFORE THE MAYOR AND CITY COUNCIL OF THE CITY OF WESTMINSTER HEREBY RESOLVE AS FOLLOWS:

<u>SECTION 1.</u> The above recitals are true and correct by this reference incorporated herein.

SECTION 2. Resolution No. 5064 is hereby repealed.

<u>SECTION 3.</u> The duties and responsibilities of the dissolved Monuments and Memorials Committee are hereby assigned to the Parks and Recreation Commission.

<u>SECTION 4</u>. The Mayor shall sign as to the passage, approval, and adoption of this Resolution.

<u>SECTION 5</u>. The Interim City Clerk shall certify to the passage and adoption of this resolution and shall affix their signature and City Seal and that same shall be entered into the Book of Resolutions.

#### **RESOLUTION NO. 5064**

#### A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF WESTMINSTER, ESTABLISHING THE MONUMENTS AND MEMORIALS COMMITTEE

WHEREAS, by formal action on July 14, 2021, the City Council stated its desire to establish a committee to review all requests from private groups or individuals for proposed monuments, plaques, donor tiles, structures, markers, any other memorial, and modifications to existing monuments on any city property; and

WHEREAS, the City Council seeks to establish the Monuments and Memorials Committee to serve this purpose.

NOW, THEREFORE THE MAYOR AND CITY COUNCIL OF THE CITY OF WESTMINSTER HEREBY RESOLVE AS FOLLOWS:

<u>SECTION 1.</u> The Monuments and Memorials Committee is established by this resolution.

#### SECTION 2. Purpose.

The purpose of the committee is to serve in an advisory capacity to the City Council to provide an independent review of proposed monuments, plaques, donor tiles, structures, markers, any other memorial, and modifications to existing monuments on any city property.

SECTION 3. Committee Responsibilities.

The committee responsibilities will be to review all new requests for proposed monuments, plaques, donor tiles, structures, markers, any other memorial, and modifications to existing monuments on any city property. The committee will also be required to review a historical report that must be provided with each proposal. The committee will forward their recommendations to the City Council for their consideration.

SECTION 4. Committee Lifespan.

The committee members appointed by Council will serve at the pleasure of the appointing council member and serve until the said council member leaves office or replaces his/her appointee. At-large members would be replaced by a majority vote of Council. City Council action will be required to terminate committee.

#### SECTION 5. Council Composition.

The committee shall consist of 5 members, with each Council Member appointing a single representative. In addition, the Committee will have 4 at-large members representing each of the following groups:

- Vietnam War Memorial in Westminster, Inc.;
- Coalition of the Republic of Vietnam Veterans Association;
- Vietnam Veterans of America (preference to local chapter); and
- Tập Thể Chiến Sĩ VNCH. Trung Tâm Tây Nam Hoa Kỳ.

The Council should make efforts to ensure a broad cross section of the community is represented. The following rules apply to all members: All members shall be at least 18 years of age. Committee members may not be current Westminster employees; Westminster City Council members; or any vendor, contractor, or consultant with active contracts or agreements with the City of Westminster. In making its appointment to the committee, the Council may, at its discretion, consider various factors applicable to each candidate including, but not limited to, the candidate's professional and educational background which supports or complements the purpose of the committee.

#### SECTION 6. Committee is Advisory.

Advisory bodies play an important role in City government by assisting and advising the City Council. The primary role of an advisory body is to provide recommendations to the City Council, the elected policy-making body of the City. The advisory body's role will be to review all requests for proposed monuments, plaques, donor tiles, structures, markers, any other memorial, and modifications to existing monuments on any city property. The committee will facilitate the review of all requests and ultimately forward recommendations to the City Council for its consideration.

SECTION 7. Committee Organization and Use of Existing City Practices.

The committee and its members shall:

- Elect the Chair and Vice Chair.
- Operate in accordance with the Ralph M. Brown Public Meetings Act and shall conduct its meetings in accordance with the provisions thereof.
- A quorum shall consist of at least five members of the committee. A copy of the approved minutes shall be forwarded to the City Clerk in accordance with the Public Records Act.
- Comply with all State and local mandated conflict of interest economic interest disclosure requirements.
- Receive no compensation for service on the Committee.

SECTION 8. Staff Support/Authority of Committee.

Staff from the Public Works and Community Services and Recreation Departments will have primary responsibility for providing administrative support to the Committee as shall be consistent with the Committee's purposes. The City Manager or his/ her designee may also act as staff liaison to the Committee.

SECTION 9. The City Clerk shall certify to the passage and adoption hereof.

#### VIETNAM WAR HISTORY

THE GENEVA ACCORDS OF 1954 CREATED NORTH AND SOUTH VIETNAM WITH THE 17TH, PARALLEL AS THE DIVIDING LINE BETWEEN THE COMMUNIST AND THE REPUBLIC SYSTEM WITH THE AGREEMENT THAT AN ELECTION WILL BE HELD WITHIN TWO YEARS TO UNIFY THE TWO STATES INTO ONE DEMOCRATIC COUNTRY. THE ELECTION NEVER HAPPENED. WHILE THE NORTH WAS CONTINUOUSLY TRYING TO TAKE OVER SOUTH VIETNAM. IN 1960, THE NATIONAL LIBERATION FRONT FORMED WITH NORTH VIETNAM BACKING AS THE POLITICAL WING OF THE ANTI-GOVERNMENT INSURANCY IN SOUTH VIETNAM STARTING FROM 1962, WITH SUPPORT FROM THE SOVIET UNION. CHINA AND OTHER COMMUNIST ALLIES, NORTH VIETNAM CHANGED ITS GUERILLA AND TERRORIST TACTICS TO BATTLES ON LARGER SCALES, CONTINUALLY ATTACKING IMPORTANT MILITARY BASES AND CITIES IN SOUTH VIETNAM. ON ITS END SOUTH VIETNAM STROVE TO DEFEND ITSELF AGAINST THE NORTH'S INVASION WITH SUPPORT FROM USA, AUSTRALIA, THAILAND, KOREA AND OTHER ALLIES. HOWEVER UNDER STRONG PRESSURES FROM THE ANTI-VIETNAM WAR MOVEMENT IN THE U.S., THE GOVERNMENT GRADUALLY WITHDREW ITS TROOPS AND MILITARY SUPPLIES. IN 1973, THE PARIS ACCORDS WAS SIGNED WITH AN ATTEMPT TO END THE WAR. THE AGREEMENT WAS THAT A CEASE FIRE BE IN PLACE IN SOUTH VIETNAM NEVERTHELESS, THE NORTH KEPT ON VIOLATING THIS PEACE TREATY AND EVENTUALLY TOOK OVER THE SOUTH ON APRIL 30, 1975 AFTER A MASSIVE REGION -WIDE ATTACK.
