On 12/3/23, at approximately 1949 hours, officers were dispatched to the 15000 block of Beach Boulevard reference a traffic collision possibly involving an intoxicated female driver. SUBJECT: Attempted robbery at Cest Si Bon

On December 8, 2023, at approximately 2:55 AM, a patron at the Cest Si Bon bar (6640 Westminster Blvd.) reported a masked subject attempted to rob him at gun point in the parking lot. The patron did not have any money to take, resulting in the suspect fleeing on foot from the location. The patron provided a brief description of the subject and his direction of travel towards Home Depot to WPD Dispatch personnel. Several WPD personnel arrived on scene within minutes and located a possible suspect in the shopping center. After an extensive investigation, interviews with witnesses and reviewing CCTV, he was identified as the correct suspect. An extensive search was conducted of the shopping center which resulted in recovering the clothing and firearm (22 cal. pistol) used during the attempted robbery. The suspect was later booked at Orange County Jail.

SUBJECT: Officer Involved Shooting

This evening at around 4:22 PM, WPD officers responded to Motel 6, located in the 6600 block of Westminster Boulevard (near the 405), in reference to a report of a male subject sitting on top of a car (roof) in his underwear. The reporting party told police dispatchers the male subject was acting erratically and was concerned for his welfare. Upon arrival, officers saw the subject appeared to be holding a rifle in his hands and was yelling the "devil was trying to kill him." Officers requested guests in the surrounding area to remain in their rooms and away from windows and doors.

Officers made contact with the subject, who pointed the rifle at them. At this point, an officer-involved shooting took place. The subject fell off of his car and began walking toward officers before collapsing. The officers immediately rendered first aid to the subject. The Orange County Fire Authority responded and transported the subject to UCI Medical Center in Orange. At the time of this press release, the suspect was in surgery, and his condition is unknown.

It is the policy of the Westminster Police Department to conduct a thorough investigation into all officer-involved shootings. These investigations are handled by the Department's Professional Standards Unit (PSU). In addition to this investigation, the Orange County District Attorney's Office Bureau of Investigation conducts its own independent investigation.
