The Community Services and Recreations Commission advises Council on matters pertaining to the acquisition and development of parks, recreational and human service facilities; the beautification and improvement of the environment of the city; the promotion of recreational programs within the city; plan and coordinate all activities and human service needs and programs for the community; solicit to the fullest extent possible the cooperation of the school authorities and public and private agencies interested in youth program activities; and perform such other duties as may be prescribed by the City Council. The Personnel Board shall hold hearings and make recommendations on any matter pertaining to personnel administration within the limits of the request. The Personnel Board shall hear written appeals from disciplinary actions, dismissal, demotion, suspension or alleged violation of the rules and regulations, including but not limited to the rules set forth in the City's Personnel Manual adopted by Resolution No. 2566 and any amendments thereto, when such appeal is made by any person in the classified service, and shall certify its findings and recommendations to the City Manager and the City Council.
