On Wednesday, January 31st, 2024, the Westminster Police Department conducted an outreach event to address the growing number of homeless individuals congregating within our respective city. Westminster Police Officers, along with our Community Outreach Coordinators and members of the Community Preservation Unit, joined in a collaborative effort to focus on solutions to solve some of these issues. The event took place in specific designated areas across the city where our homeless community members tend to congregate. This event involved both outreach and engagement with our homeless community who are willing to accept services, but also focused on enforcement of local and state laws.

The group's collaborative efforts focused on the following:

- 16 Subjects contacted, no requests for follow up outreach services
- 10 Subjects arrested
- 2 citations issued
- 3 encampments cleaned up
- 5 Truckloads of discarded items were removed by CPU
- 10 Shopping carts removed

It should be noted, all homeless persons contacted were provided information about available resources. An option for coordination into shelter facilities was also provided.

On Monday, February 12, 2024, at approximately 4:42 A.M., WPD Officers responded to the 15000 block Brookhurst St reference a vehicle burglary. The reporting party advised a male and female suspect slim jimmied his vehicle to gain entry and stole headphones and miscellaneous items from the victims' vehicle. At approximately 10:03 AM, the suspect was located hiding in a neighboring backyard on Jenner St. He was detained and taken into custody. A pellet gun resembling a real firearm was recovered during the incident. He will be booked at Orange County Jail for brandishing a weapon and criminal threats.
