On March 3, 2024, at approximately 1:45 PM, WPD Patrol responded to Macy's at the Westminster Mall in reference to an E-bike theft. Two E-bikes had been stolen from outside the store, valued at \$5,200.00. Macy's Loss Prevention assisted WPD in obtaining CCTV footage of the theft. Through CCTV, basic suspect descriptions were obtained along with a general vehicle description the E-bikes were loaded into. One of the E-bikes had a GPS tracker attached underneath the seat.

At approximately 3:52 PM, the victim advised WPD that the GPS tracker on the E-bike had come to a stop at 8970 Bolsa Ave. The tracking application traced the E-bike inside a parked Ram rental panel van in the parking lot. WPD Patrol responded and located seven occupants inside the van along with both E-bikes. Two occupants were identified as the bicycle thieves, 2 more were arrested for unrelated arrest warrants and the remaining occupants were released at the scene. Both E-bikes were returned to their owners.

The four subjects arrested during this case were all booked at Orange County Jail.

#### **Assault with a Deadly Weapon Arrest:**

On Sunday, March 10, 2024, at approximately 7:13 P.M., WPD Officers responded to the area of Brookhurst St and McFadden Ave reference a vehicle vandalism investigation. During the investigation, it was ascertained that the suspect and victims were involved in a road rage incident. While at Brookhurst St and McFadden Ave, the suspect became irate, brandished a hammer and threw the head of a hammer through the victim's car windshield nearly striking the front passenger. The suspect then collided into the victim's vehicle while he attempted to flee. The suspect fled the scene after the collision. The suspect was later located and arrested. On Thursday March 14, 2024 at approximately 10:30 P.M., WPD Officers were dispatched to the 5500 block of Garden Grove Blvd. reference a road rage incident. The victim was driving when they were confronted by a suspect in another vehicle for unknown reasons and challenged to a fight. The victim drove away from the suspect and would pick up a passenger in the area where they were confronted again. The suspect threw a plastic cup filled with alcohol at the victim's vehicle into an open window. The suspect then threw an approximate 1' long metal pole towards the vehicle, but the victim was able to avoid being struck by quickly driving away. Both victims feared the suspect was trying to physically harm them by throwing a metal object at them while in the vehicle.

The victims attempted to leave the area when the suspect exited his vehicle and threw the metal pole at their vehicle again, striking the rear portion of the vehicle causing damage. The victim was able to obtain a license plate and suspect description. At the time of the original investigation, the suspect was not located.

Several hours later, the victims returned to the area to drop the passenger off at their residence when they were confronted by the suspect again. WPD responded and located the suspect in the area. The suspect was arrested without incident. The suspect was booked at Orange County Jail for multiple felonies.
