On March 15, 2024 at approximately 1:00 PM, Westminster Police Officers responded to the 7300 block of 21st Street reference a stabbing. When officers arrived, they found several neighbors holding down a man, who had just stabbed his roommate and an additional neighbor. Officers on scene were able to take the suspect into custody without incident and began to render first aid to both victims on scene. Lifesaving efforts were continued by Orange County Fire personnel and the victims were transported to a local trauma center. One of the victim's ultimately succumb to his wounds and was pronounced deceased at the hospital.

During the investigation, officers learned that the fight originated between roommates inside an apartment, where the suspect had stabbed his roommate. This first victim sustained three non-life-threatening stab wounds and is being treated at a local hospital. A neighbor heard the commotion, including a man screaming for help, and went to assist. At this time, the suspect turned his attention to the neighbor/victim and chased him outside. The suspect ultimately caught up to the deceased and stabbed him numerous times. Another citizen saw what was happening and was able to intervene and successfully removed the knife from the suspect. The citizen was able to hold the suspect down until police arrival. WPD Detectives and Forensics personnel are on scene continuing the investigation

This appears to be an isolated incident and there are no known threats to the public. The suspect is in custody and will be booked into Orange County Jail for numerous charges, including murder.



SUBJECT: <u>SWAT activation following investigation</u>

On 3/28/2024, the Westminster Police Detective Unit received information that a 14-year-old female was being trafficked for the purpose of prostitution by a suspect out of a motel in the city. The investigation led the detectives to locating the female in a room accompanied by a female adult. The 14-year-old was a reported missing person out of Kern County.

During the investigation, detectives learned that she had been trafficked by a named suspect. Detectives also learned that the female had been sexually assaulted by the male. The suspect had prior convictions for human trafficking of a minor, firearms possession and robbery. The female was provided with victim services and detectives continued to investigate.

On 3/29/2024, Detectives obtained a lead that the suspect was possibly back in the city. Detective's ultimately located the suspect and attempted to stop him. A short pursuit took place, where the suspect crashed into two parked vehicles, disabling his own car. The suspect then fled on foot. During a quick search of the disabled vehicle, a loaded firearm was located in the car.

Westminster Patrol and Westminster Detectives were able to successfully contain the suspect for several hours around the 8000 block of 21st Street. Due to the severity of the case, the location of the loaded firearm and other contributing factors, West County SWAT was activated to assist with the search of the suspect. After an extensive yard to yard search, the suspect was located hiding in a backyard.
