On April 1<sup>st</sup>, 2024, at about 12:40 P.M., Westminster PD received a suspicious phone call stating there was an active school shooting taking place at McGarvin Middle School. McGarvin was contacted via phone and stated there was no incident taking place. Officers immediately responded to McGarvin and met with school staff upon arrival. They confirmed there was **NO** shooting at the school. Officers and school staff walked the school, and there was nothing suspicious.

At about 1:13 P.M., McGarvin Middle School received a call from a "robotic voice" stating a bomb was placed in the boy's restroom. Officers confirmed there was **NO** bomb in the restroom, and the school was still secure.

It appears these were swatting incidents on "April Fool's Day." Officers checked the other surrounding schools, and each was secure.

On 4/2/2024, at approximately 1025 hours, the Westminster Police Department resonded to 9550 Bolsa Avenue reference a traffic collision involving a vehicle and a child.

Westminster Police Officers arrived and found an 18 month old child had been struck by a vehicle. Personnel from the Orange County Fire Authority also responded. The child was transported to a local trauma center whe he unfortunately succumbed to his injuries. During the investigation, it was discovered that the child was walking West through the parking lot as a vehicle entered the parking lot and struck the child. The involved driver remained at the location of the collision and is cooperating with the investigation.

The Westminster Police Department's Traffic Bureau responded to the scene and is handling the ongoing investigation.

On 04/04/2024, at around 1:00 AM, WPD received a FLOCK hit on a reported stolen vehicle in the area of Westminster and Magnolia. Several minutes later, a WPD officer observed the vehicle in the 7-Eleven parking lot at Magnolia and Edinger. The vehicle exited the lot onto WB Edinger and drove a short distance before stopping on Edinger just W/O Magnolia. Four male subjects fled from the vehicle and jumped a wall NB into the adjacent residential tract. During their flight from the vehicle, the suspects had dropped a replica firearm and some masks. A perimeter was quickly established, and a request was broadcast for an airship, a K-9 unit and additional outside agency units to assist with perimeter/search team. Anaheim's airship, Angel along with Huntington Beach Police units arrived to assist. As a search team was being formed, an Uber driver was contacted in the area and stated he was supposed to pick up a client at an address on Garnet. Airship Angel checked this residence and observed several subjects hiding under an overhang in the backyard. The search team set up on the residence and K-9 announcements were made. Four subjects surrendered and were detained without incident. All four, two of whom were juveniles, were eventually taken into custody.
