On June 29, 2024, at approximately 12:00 AM, Westminster Police Officers were dispatched to the 7000 block of Garden Grove Boulevard reference a shooting. During the investigation, officers determined a shooting took place after two disgruntled customers shot towards two employees, who were standing inside an occupied business. The employees were able to take cover and were not struck by the gunfire. Prior to police arrival, the suspects fled the location.

While on scene, officers sent out a county wide broadcast of the crime. A short time later, Westminster Police was notified of similar suspects being involved in an additional crime in the City of Anaheim, also involving a firearm. The suspects had barricaded themselves in a nearby home in the City of Anaheim.

With the updated information, members of the Westminster Police Major Crimes Unit were called into work and began to work in collaboration with the Anaheim Police Department. During the investigation, Anaheim Police took the suspects into custody. Westminster Police Major Crimes Detectives were then able to get positive identifications on both suspects for the crimes committed in the City of Westminster. The firearm used the in the crime was later located and both suspects were booked into Orange County Jail for several felonies, including but not limited to, discharging a firearm into an occupied building as well as assault with a deadly weapon. This appears to be an isolated incident.





SUBJECT: 4th of July Holiday Recap

Now that the Fourth of July holiday festivities have concluded, I wanted to share some of the data we collected. This information will help us formulate our staffing levels and enforcement for next year.

As expected, calls for service (CFS) related to illegal fireworks increased over the weekend and continued through July 6th. Between June 28th and July 6th, WPD received **170 calls** for service (CFS) related to complaints about illegal fireworks. For comparison, in 2023, from June 28th through July 6th, our dispatch center received **128** calls for service (CFS) related to complaints about illegal fireworks.

Total CFS from June 28th through July 6th this year (includes non-firework related CFS): 2,141

Total CFS June 28th through July 6th of last year (includes non-firework related CFS): 2,196

This year, additional officers were assigned to a Fireworks Enforcement Detail the weekend prior to the Fourth of July (June 28th and June 29th), the Fourth of July, and July 5th. Officers assigned to this detail handled **93** calls for service related to illegal fireworks.

### Enforcement action that was taken during the Fourth of July weekend.

- Two citations were issued for possession of illegal/dangerous fireworks. These citations encompass a \$1,000 fine.
- Three arrests for selling illegal fireworks to undercover detectives.

• Approximately 500 illegal/dangerous fireworks were seized/recovered.

In addition to the firework-related calls for service mentioned above, the following are *some* significant events that resulted in lengthy investigations from the Fourth of July through July 7th:

- Subject was arrested for indecent exposure.
- Subject was arrested in reference to a robbery investigation.
- Subject was arrested for disorderly conduct following a possible burglary in progress call involving the same subject.
- Five subjects were arrested for driving under the influence (DUI)
- Three subjects were arrested for domestic violence.
- Subject was arrested for felony vandalism.
- Subject was arrested for impersonating a veteran and embezzlement.
- An officer observed a burglary in progress, and a pursuit was initiated. Suspects are not apprehended at this time (ongoing investigation).
- Patrol checks were conducted at multiple city parks by our HLOs, and one abandoned property was cleaned up.
- Structure fire on Iroquois St. after an investigation, arson was ruled out, and the cause was most likely smoldering expended fireworks.

From the data collected, plainclothes officers were an effective option for enforcement operations. Consequently, we will implement a larger presence of plain-clothes next year. Furthermore, due to this holiday falling on a Friday in 2025, we believe our call volume will increase, necessitating additional first responders working. We will be planning accordingly.

On 7/12/2024, the Westminster Police Department's Traffic Division conducted a DUI/DL Checkpoint at Westminster Boulevard and All American Way from 8:30 PM to 3:00 AM. This location was chosen based on data indicating this geographical area has one of the highest number of injury and fatality traffic collisions in the city with DUI being one of the leading causes. The following are the results of the operation:

- 679 vehicles through the checkpoint
- 49 secondary screenings, evaulations, DL checks
- 2 impounded vehicles
- 31 citations issued
- 3 field sobriety tests conducted
- 2 DUI arrests

Funding for this operation was provided by a grant from the California Office of Traffic Safety, through the National Highway Traffic Safety Administration.
