<u>PUBLIC HEARING ITEM</u>: Case No. 2024-0188 (Zoning Text Amendment) – The City of Westminster is

proposing a Zoning Text Amendment to Chapter 17.330 (Signs) of the Westminster Municipal Code amending signage regulations for billboards. The proposed amendments would establish application review procedures and standards for the location, development, and design of new electronic billboard freeway signs. The purpose of the September 18, 2024, public hearing is for the Planning Commission to review the proposed zoning text amendments and make a recommendation to the City Council. The item was previously discussed at a public hearing during the August 21, 2024, Planning Commission meeting.

ENVIRONMENTAL STATUS: Adoption of the proposed ordinance is exempt from the California

Environmental Quality Act ("CEQA") because it is an administrative activity that will not result in a direct or reasonably foreseeable indirect physical change to the environment and is thus not a "project" as defined by State CEQA Guidelines Section 15378 (see State CEQA Guidelines, § 15060(c)(2) and (3)). In the alternative, even if adoption of the ordinance did qualify as a project under CEQA, it would be exempt from CEQA under 15061(b)(3) of the State CEQA Guidelines, which provides that a project is exempt from CEQA where it can be seen with certainty that there is no possibility that the activity in question may

have a significant effect on the environment.
