

RESOLUTION NO. 4263

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF WESTMINSTER, ESTABLISHING ALARM SYSTEM ORDINANCE VIOLATION PENALTY AMOUNTS.

WHEREAS, the Mayor and City Council enacted Ordinance No. 2458, repealing and replacing Chapter 5.50 and adding Chapter 5.51 to Title 5 of the Westminster Municipal Code, relating to alarm systems.

NOW THEREFORE, BE IT RESOLVED that the Mayor and City Council of the City of Westminster herewith establish false alarm penalties and penalties for operating unpermitted alarm systems within a 365-day period as follows.

1	- On-site written notice by officer	N/A
2	- On-site written notice by officer - Invoice for fine	\$75
3	- On-site written notice by officer - Warning letter from alarm coordinator - Invoice for fine	\$100
4	- On-site written notice by officer - Warning letter from alarm coordinator - Invoice for fine	\$150
5	- On-site written notice by officer - Warning letter from alarm coordinator - Invoice for fine	\$200
6	- On-site written notice by officer - Warning letter from alarm coordinator - Invoice for fine	\$250
7	- On-site written notice by officer - Warning letter from alarm coordinator - Invoice for fine - Revocation of alarm permit	\$300
Additional false alarms that occur during the appeal review	- On-site written notice by officer - Warning letter from alarm coordinator - Invoice for fine	\$300
