RESOLUTION NO. 4262

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF WESTMINSTER, AMENDING RESOLUTION 4012 ESTABLISHING ALARM SYSTEM PERMIT FEE AMOUNTS

WHEREAS, the Mayor and City Council of the City of Westminster have approved the study entitled "Cost Control System for the City of Westminster" dated May 5, 1988, and prepared by Management Services Institute (MSI); and

WHEREAS, the annual update study was performed by Revenue & Cost Specialists, LLC (RCS) (formerly MSI) to determine the total cost of providing special services by the City of Westminster; and

WHEREAS, by adoption of Ordinance No. 2097 on Chapter 11, 1988, the Mayor and City Council have adopted the Fee and Service Charge Revenue Cost Comparison System to recover the costs reasonably borne for special services; and

WHEREAS, by adoption of Resolution No. 4012 on July 26, 2006, the Mayor and City Council have established fees and charges for special services provided by the City; and

WHEREAS, by adoption of Resolution No. 4215 on February 11, 2009 (renumbered to Resolution No. 4240 on May 27, 2009), the Mayor and City Council have established a criminal justice administration fee for persons who are arrested and booked into the Westminster Detention Center and later convicted of the offense related to the arrest;

WHEREAS, the Mayor and City Council enacted Ordinance No. 2458, which establishes alarm system new and renewal permit fees; and

NOW THEREFORE, BE IT RESOLVED that the Mayor and City Council of the City of Westminster amend Resolution 4012 by including fees for alarm system permits, including permit renewal fees.

SECTION 1 Resolution No. 4012 is amended to include the following fees:
